



Privacy Policy

This Privacy Policy explains how {Driblo Ltd} (“Driblo,” “we,” “our,” or “us”) collects, uses, and protects your personal information when you use our website, trading platforms, and services (the “Services”). We are committed to safeguarding your privacy and handling your data transparently and responsibly.

1. Information We Collect

We may collect the following categories of information:

- * Identification Data: name, date of birth, nationality, government-issued IDs (for KYC/AML).
- * Contact Data: email, phone number, billing address, correspondence.
- * Financial Data: payment details, payout details, billing history.
- * Technical Data: IP address, device type, browser type, cookies, analytics data.
- * Usage Data: platform activity, login history, assessment progress.
- * Marketing Data: newsletter preferences, lead forms, survey responses.

2. How We Use Your Data

We process your personal data for the following purposes:

- * Account creation and authentication.
- * Processing evaluation fees, payouts, and billing.
- * Compliance with AML/KYC and sanctions screening.
- * Monitoring platform performance and preventing fraud.
- * Providing customer support.
- * Sending service updates, marketing campaigns, or newsletters (where permitted).
- * Internal analytics and improving our Services.

3. Legal Basis for Processing (EU/UK Users)

For users located in the EU/UK, we rely on the following legal bases:

- * Contractual necessity: to provide the Services you request.
- * Legal obligations: AML/KYC, tax, and regulatory compliance.
- * Legitimate interests: platform security, fraud prevention, analytics.
- * Consent: for marketing communications and cookies.

4. Regional Disclosures

We comply with different data protection laws depending on your location.

4.1 European Union / UK (GDPR, UK GDPR)

You have the right to:

- * Access, correct, or delete your data.
- * Restrict or object to processing.
- * Data portability.
- * Withdraw consent (e.g., for marketing).

We may share data with trusted third parties strictly necessary to provide our Services, such as:

- * Trading Platforms (e.g., MetaQuotes MT5, TradingView integration).
- * Payment Processors for fees and payouts.
- * KYC/AML providers for identity verification.
- * Cloud hosting (AWS).
- * CRM & analytics providers to improve user experience.

We do not sell your personal data.

6. Data Storage & Retention

- * Data is stored on AWS servers located in the EU and/or other secure regions.
- * Retention: personal data is stored as long as your account is active + up to 365 days after closure, unless longer retention is required by law (e.g., AML).

7. Cookies & Tracking

We use cookies and similar technologies for:

- * Session management.
- * Analytics (site performance, usage).
- * Marketing/advertising.

You can manage cookie preferences through your browser.

8. Security

We implement industry-standard security measures including encryption, firewalls, and access controls. However, no system is 100% secure, and users accept some risk when transmitting data online.

9. Children's Privacy

Our Services are not directed to anyone under 18. We do not knowingly collect personal information from minors.
